Equal Opportunities Policy

Introduction

At Ysgol Iolo Morganwg we want to provide everyone with the chance to develop fully as individuals, to enhance their role within the school and to help further the school's cause within the community.

This entails having certain roles and responsibilities, collectively and individually. These pertain in varying degrees to various items of national legislation, local initiatives and other school policies relating to Access, Inclusion, Race Relations, Bullying and Discrimination.

Aims and objectives

- 2.1** In this school, we do not discriminate against anyone, be they staff or pupil, on the grounds of their colour, disability, ethnic or national origins, gender, nationality, sexual orientation, race or religion. This is in line with various pertinent Acts and covers both direct and indirect discrimination.

- 2.2** We promote the principles of fairness and justice for all through the education that we provide in our school.
- 2.3** We ensure that all pupils have equal access to the full range of educational opportunities provided by the school.
- 2.4** We constantly strive to remove any forms of indirect discrimination that may form barriers to learning.
- 2.5** We ensure that all recruitment, employment, promotion and training systems are fair to all, and provide opportunities for everyone to achieve.
- 2.6** We challenge stereotyping and prejudice whenever it occurs.
- 2.7** We celebrate the cultural diversity of our community and show respect for all minority groups.
- 2.8** We are aware that prejudice and stereotyping is caused by low self-image and ignorance. Through positive educational experiences and support for each individual's point of view, we aim to promote positive social attitudes and respect for all.

3 The role of governors

- 3.1** The governing body has set out its commitment to equal opportunities in this policy statement, and it will continue to do all it can to ensure that all members of the school community are treated fairly and with equality.

- 3.2** The governing body seeks to ensure that people with disabilities are not discriminated against when applying for jobs at our school. The governors take all reasonable steps to ensure that the school environment gives access to people with disabilities.
- 3.3** The governing body will, in its annual report, make reference to arrangements for disabled pupils.
- 3.4** The governors welcome all applications to join the school, whatever background or disability a child may have.
- 3.5** The governing body ensures that no child is discriminated against whilst in our school on account of their sex, religion or race. So, for example, all children have access to the full range of the curriculum, and regulations regarding school uniform will be applied equally to boys and girls. If a child's religion affects the school uniform, then the school will deal with each case sensitively and with respect for the child's cultural traditions.

4 The role of the headteacher

- 4.1** It is the headteacher's role to implement the school's equal opportunities and is supported by the governing body in so doing.
- 4.2** It is the headteacher's role to ensure that all staff are aware of the school policy on equal opportunities, and that teachers apply these guidelines fairly in all situations.
- 4.3** The headteacher ensures that all appointments panels give due regard to this policy, so that no-one is discriminated against when it comes to employment or training opportunities.

- 4.4** The headteacher promotes the principle of equal opportunity when developing the curriculum, and promotes respect for other people in all aspects of school life.
- 4.5** The headteacher treats all incidents of unfair treatment and any racist incidents with due seriousness and in accordance with the relevant policy.

5 The role of the class teacher

- 5.1** The class teacher ensures that all pupils are treated fairly, equally and with respect. We do not discriminate against any child.
- 5.2** When selecting classroom material, teachers pay due regard to the sensitivities of all members of the class and do not provide material that is inappropriate in nature. Teachers strive to use material that provides positive images of ethnic or other minority groups and that challenges stereotypical images.
- 5.3** When designing schemes of work, we use this policy to guide us, both in our choice of topics to study, and in how to approach sensitive issues.
- 5.4** All our teachers challenge any incidents of prejudice or racism. We record any serious incidents in the school log book, and draw them to the attention of the headteacher. Teachers support the work of ancillary or support staff and encourage them to intervene in a positive way against any occurrence of discrimination.

6 Monitoring and review

6.1 It is the responsibility of our governing body to monitor the effectiveness of this Equal Opportunities policy. The governing body does this by:

- monitoring the progress of pupils of minority groups and comparing it to the progress made by other pupils in the school;
- monitoring the staff appointment process, so that no-one applying for a post at this school is discriminated against;
- requiring the headteacher to report to governors on an annual basis on the effectiveness of this policy;
- taking into serious consideration any complaints regarding equal opportunity issues from parents, staff or pupils;
- monitoring the school behaviour and exclusions policy, so those pupils from minority groups are not unfairly treated.
